

## IN FRANCE, EVERYBODY CAN HAVE ACCESS TO HEALTHCARE

I don't have papers to stay in France, can I ask for hospital papers?

FRENCH PEOPLE
AND FOREIGNERS CAN ASK
TO HAVE HOSPITAL PAPERS
TO SEE A DOCTOR AND RECEIVE
A TREATMENT.

Even if you don't have papers, you can ask to have hospital papers. We advise you to give true name and adress: don't use the card of your friend because you will not receive the results and it can be dangerous for you and your friend.

When you have AME, you do not pay if you see a general doctor, a dentist or if you need to have surgery. You will also not pay for drugs, laboratory tests, contraception and abortion.

THERE ARE DIFFERENT
TYPES OF HOSPITAL PAPERS,
DEPENDING ON YOUR
SITUATION.

You need to go to the hospital paper office of the city where you have your address to ask for it.

AME and CMU last for 1 year.
Don't forget to renew it two
months before the expiry date.

IF YOU DO NOT HAVE RESIDENT PERMIT TO STAY IN FRANCE, YOU CAN ASK FOR AIDE MÉDICALE D'ETAT.

You have to bring:

- \* an ID paper (passport, birth certificate...)
- \* an address paper
  ("domiciliation" or a proof
  of your own address like
  EDF bill + letter from the owner
  + copy of the ID of the owner)
- \* 1 photo
- documents with your name and dates showing that you have been in France for the last 3 months (for example, a letter from your social, results from hospital...).

IF YOU HAVE RESIDENT PERMIT LIKE OFPRA PAPER, RÉCÉPISSÉ OR CARD AND YOU DO NOT WORK OR YOU DO NOT HAVE A LOT OF MONEY, YOU CAN HAVE CMU.

You have to bring:

- \* resident permit card, récepissé or papers that show you have appointment in Préfecture.
- \* an ID paper
- \* an address paper
- \* 1 photo
- documents with your name and dates showing that you have been in France for the last 3 months.
